### **RULES OF PARTICIPATION**

### 1. ORGANISERS

### 2. VENUE, DATES AND TIMES

MAINTENANCE 2023 will be held at Bilbao Exhibition Centre – BEC, in Ansio-Barakaldo (Biscay) from **06**<sup>th</sup> **to 08**<sup>th</sup> **June 2023**, and will be open from Tuesday to Thursday **from 9.30 to 18.00 for visitors**, and **from 8.30 to 19.00 for exhibitors**. The stands will be manned and the material on display will be uncovered during visiting hours.

### 3. EXHIBITORS AND PRODUCTS ADMITTED

- All natural or legal persons, whether public or private, whose activities are deemed to fall within the sectors set out in the application form may apply to take part in the event.
- The manufacturers of the products admitted to the exhibition and the agents and representatives of the products admitted to the exhibition may exhibit.
- Models, photographs, and films shall only be admitted as a complement to the material exhibited and provided that they
  correspond to approved products.
- Purely informative stands, with no material on display, shall not be admitted, except when shown by non-profit associations and institutions.
- · Material not complying with the foregoing conditions shall be removed at the exhibitor's expense and risk.
- Advertising by non-exhibiting companies and the distribution of advertising material outside the stands are not permitted.

# 4. HIRING AND FORMS OF PARTICIPATION

### **HIRING:**

- You can hire areas and purchase services by a fully filled-in application form to the Event's Management, enclosing payment for a deposit of €60 +VAT/m², which shall be deducted from the total amount of participation according to Art. 7.
- The minimum space to be hired is 12m² for the ALL IN Stand and 16m² for the ALL IN ADVANCED Stand, according to the format hired. Fractions of m² will be invoiced as full m².
- Promotional packs: all participation formats will require purchasing a promotional pack, the minimum version being the BASIC Pack, as stated in the participation application form.
- The priority deadline for receiving preferential applications to participate is 20 January 2023. Applications will be considered subject to demand and available space.
- The Organisers reserve the right to change the area or location allocated if circumstances so require, without such entailing any right to compensation.
- Grouped participations: They will be admitted according to the conditions set out by the Organisers. For grouped participation of 2 companies, a minimum of 16m² must be hired. For other grouped participations, please consult the Organisers."
- The location of the stand hired in the exhibition area will be decided by the Organisers, who may offer alternatives and will attempt to adapt to the needs of the participating company, but under no circumstances can the desired location be guaranteed.
- Services may be hired in the online shop in the "Exhibitors' private area," using the "user" and password provided.



### 5. EXHIBITOR'S RIGHTS

# Registration covers the following services and supplies:

- Participation in the exhibition area according to your chosen format.
- You can use the "Username" and "Password" to register in the "Online Directory of Exhibitors" and order additional services in the "Online Shop" in the "Exhibitor's Private Area" on the event's website.
- Exhibitor passes: Application through the "Exhibitors' Private Area" for 4 passes up to 20 m² and 2 more for every 20 m² or fraction thereof, up to a maximum of 6.
  - Employees of the company who will not be manning the stand can register as visitors to obtain their accreditation.
- Assembler passes: Application through the "Exhibitors' Private Area" for assembler passes.
- First cleaning before the exhibition opens, for the ALL IN and ALL IN ADVANCED formats. This cleaning is not included in the case of FREE AREA.
- Daily cleaning during the event.
- Disposal of waste, shavings, and residues.
- Mandatory insurance: damage and liability insurance (see details in Art.6).

- **Press conference.** BEC can assist you in organising a press conference, with media coverage for greater visibility. This service is subject to the date on which we receive the application form.
- **VIP Lounge.** A free ticket to the VIP lounge for your company.

### 6. MANDATORY INSURANCE

The insurance policies that the BEC will take out for this event, **included in the price of participation**, according to Article 33 of the BEC's General Participation Regulations, will have the following basic features:

# **Damage Insurance**

- Basic cover: Fire and theft of goods on display and in stands, including loading and unloading at the exhibition site. Packaging is
  also included, with a first risk limit of €10,000 and an excess of €1,000 per claim.
- Insured goods: General commercial goods, including computer and household appliances (brown line), with an excess of €300 per claim, and the following exceptions: corrosive, inflammable, explosive, poisonous, radioactive goods, live animals and plants, cash, commercial or banking materials, securities and securities coupons, jewellery and jewellery items, objects d'art and antiques, prepaid cards, machinery, or other types of goods during assembly and disassembly operations.
- Insured capital: The insured capital shall be that declared by the exhibitor when applying for admission. However, there is a minimum mandatory capital, set at €12,000. If the exhibitor does not make a capital declaration, the Organisers will take out the fixed minimum, holding BEC harmless from any type of liability for excess and/or insufficient insured capital.
- Premium: Rate of 8.6 ‰ (per thousand) to be applied to the value provided by the exhibitor or, if taken out, to the minimum capital requirement. Minimum premium: €103.20.
- Excess: The amount of the excess will depend on the conditions available on the insurance market when the policy is taken out.

# **Public Liability Insurance**

- Basic cover: Property and bodily damage caused to third parties as a result of the event, expressly excluding Public Liability arising
  from accidents at work suffered by personnel employed by the exhibitor and/or personnel subcontracted by the exhibitor.
- Compensation limit: €1,200,000 per claim and for all claims occurring at the event, with a sub-limit of €150,000 per victim for personal injury.
- Premium: €110.00 per exhibitor.

### The coverage period is from 01 to 11 June 2023.

So that the exhibitors check the precise details of the coverage, limitations and exclusions in the policies taken out, the insurance policies will be available to exhibitors at the Event Management offices.

# 7. FINANCIAL AND PAYMENT CONDITIONS

Together with the participation application, the Exhibitor must pay a deposit of €60 + VAT/m² as an advance payment, which will be deducted from the total participation fee. This sum will be refunded if the future exhibitor does not receive authorisation to exhibit.

# The outstanding amount will be paid on 15 March 2023.

Registrations received after 15 March 2023 will be invoiced immediately upon notification of the exhibitor's location and payment by bank transfer will be due immediately.

Payments will be made by bank transfer or by direct debit, if stated on the application form. Deadline for applying for direct debit: 15 March 2023.

**Cancellation of participation:** If the exhibitor cancels their participation, which must be done in writing to <a href="maintenance@bec.eu">maintenance@bec.eu</a> they shall forfeit all amounts paid.

### 8. ASSEMBLY, GOODS RECEIPT AND DISASSEMBLY

# Assembly of stands and entry of goods.

It will start on 01 June 2023 at 8.00 and will end on 05 June 2023 at 15.00.

### Disassembly of stands and removal of exhibition material.

It will start on **09 June 2023 at 08.00 and will** end on **11 June 2023 at 20.00**.

At the end of the event, the space must be left in the same condition in which it was found. Any alterations to the floor and walls must be repaired within the same period.
